### Mayor's Report and Comments

- A. Introduction of Rachel Raggio from TOASE Mayor Conway welcomes Rachel Raggio, an Associate Attorney with Toase to the team.
- B. November 2023 Sales Tax update: Sales tax trended up in November coming in at \$94,707.
- C. Proclamation for retired Mayor Bob Cornett Mayor Conway presents Mrs. Sandy Cornett with a proclamation from the City of Cresson honoring the retired mayor who passed away on December 31, 2023. The proclamation will hang in the back of the chambers to honor Bob next to his portrait. The city staff also put together a little goodbye sentiment as well.
- **D. Clean up blitz in our community** New year, new goals for cleanup. We have several clean up efforts in the works and will strive to really push in January to get the projects completed. It is a lengthy process, and it requires many steps, but we will deliver.

#### **Deliberation Agenda**

A. Consider and possibly take action to approve or disapprove a Site Plan Application from Truck Parkz USA LLC for Lots 6 & 7 of Cresson Crossroads, Phase 1. Chuck Stark, with Barron & Stark, is present to answer council questions. Councilperson Becker makes a motion to conditionally approve the site plan. This can move to full approval upon city engineer, Glenn Breisch, approval. Councilperson Keeney seconds the motions. 4 ayes and 0 nays. The motion is passed unanimously.

- B. Consider and possibly act to approve or disapprove a 3-year donation to Visit Granbury to help with the costs of hosting the Spartan and Tough Mudder races. Councilperson Becker makes a motion to continue to donate \$2,000 a year for 3 years to Visit Granbury for sponsorship of the Spartan and Tough Mudder races. Councilperson Clement seconds the motion. 4 ayes and 0 nays. The motion is passed unanimously.
- C. Approve the minutes from the City Council meeting held on November 14, 2023. Councilperson Becker makes a motion to approve the minutes as written. Councilperson Keeney seconds the motion. 4 ayes and 0 nays. The motion is passed unanimously.
